- ◇ A dependent of an ITWA eligible employee member is exempt from this restriction if the employee has been employed for five or more consecutive years by a company which has also been a member for five or more consecutive years.
- ◇ A dependent of an ITWA eligible owner member or eligible employee member must have a minimum grade point average of 2.0.
