FROM THE DESK OF EXECUTIVE DIRECTOR BART GIESLER

I was recently invited to a meeting with INDOT that they were having with local towing companies to discuss the upcoming road construction on the Borman Expressway. As part of that meeting, the engineering company (Parsons) that is working on the project gave a presentation on a towing recovery incentive program (TRIP). They were also in the process of having meetings with the Indiana State Police, INDOT and others separately to discuss the incentive program and to gauge their interest.

Parsons discussed a similar program that they manage in Virginia that pays towing companies if they clear the scene within a designated time period (90 minutes) for certain incidents. Whoever manages the program (program manager) would contract with INDOT, and the program manager would contract with towing companies and pay them the incentives. The program manager would determine how many towing companies would be responsible for zones (there may only be one company per zone). The program manager would be responsible for determining minimum equipment and performing annual inspections.

The first part of the process would be that INDOT would need to contract with a program manager and determine the duration of the contract, define what incidents would qualify for the program (it could be all accidents or just those that involve trucks that block lanes or any other possibility that INDOT would determine slows up traffic), define response times and clearance times and exact areas that would be covered by the zone.

After INDOT and the program manager agree to terms, the program manager then would need to work with the State Police and other first responders in determining if the incident qualifies. If it qualifies for the program, the towing company that has the zone would be contacted. It would not be the next company on the rotation. They would also work with the first responders to let them know when to “turn over” the accident to the towing company to start the clock for the cleanup time.

After the program manager determines how many zones, they would accept applications from towing companies for a zone(s). As part of this process, the towing company must have designated equipment and must have completed various training programs on towing and haz-mat. The program manager will evaluate the companies and also verify the time it takes to arrive at the zone. A company with all the equipment in the world and the greatest trained staff may not get a zone because they are too far from the zone.

The program manager would not set rates for the towing company. Based on the rates in Virginia, they would reimburse qualified accidents between \$2500 and \$3500 if the accident was cleared in the proper timeframe. This amount is over and

above what is collected from the person who caused the accident. If an accident was not cleared in the allotted timeframe, the towing company would be penalized depending on how long it took to clear the scene.

INDOT has not agreed to this concept and ITWA does not know if they will or will not agree to it. We wanted you to be aware that conversations are taking place. ITWA believes that if INDOT does a TRIP, the first one will be in a heavily congested area and be used as a test project. If INDOT does determine that it is successful, they may look to expand it to other areas across the state. At this point, INDOT and their teams are still gathering information. If you are interested in learning more about this possible project for the Borman project, please let ITWA know and we will get you in touch with the appropriate person.

DOT CHAT WITH BRENT HOOVER



Hello and welcome back! If you are new to the column I would like to take a minute and bring you up to speed on who I am. My name is Brent Hoover. I am a Master Trooper with the Indiana State Police. I have started my 19th year with the ISP. I am assigned to the Commercial Vehicle Enforcement Division or CVED for short. My primary daily duty is to enforce the State and Federal Regulations for CMVs in the State of Indiana. I am certified to complete Part A and B Inspections, as well as General Haz-mat and Cargo Tank inspections. I am also a Part B Instructor for the National Training Center, which means I teach new inspectors how to inspect and document Level 1 Inspections. I have competed twice in the North American Inspectors Championships. I am the current administrator of the CVED Facebook page where I post about tips and tricks to improve your pre-trip inspections and to avoid common roadside violations.

This week I would like to write about a stop I made last week. I stopped a tow truck towing a semi-tractor backwards and only had the 4-way flashers activated.



I want to remind you that in FMCSRs 393.9 and 393.11 that a working set of tail, turn, and brake lights must be always displayed on the towed vehicles.

Not only is not having these lights a safety concern for you, but for those that are following you and your tow truck. It is an Out of Service violation as well. I would hate for someone to rear-end you coming to a stop or turning, because you failed to have the required lights. So please take a minute and make sure that your added lights are used and function properly.

Tips for Securing Insurance Coverage for Towing Services Part IV: *Liability Coverage*

My name is Ryan Leagre and I am an attorney at Plews Shadley Racher & Braun LLP. I represent towing companies in various capacities, including helping them recover the costs of responding to large accidents and navigating statutes and ordinances that regulate the industry.

As discussed in my January 2023 Legal Update, there are generally three types of insurance coverage that may pay for your services: *physical damage*, *cargo*, and *liability*. In prior newsletters, I focused on *physical damage* and *cargo* policies. This month I focus on *liability* policies. Liability policies provide coverage for “property damage” and “bodily injury” resulting from an accident. “Property damage” is often defined as “physical damage to, destruction of, or loss of use of, tangible property.” Liability insurers almost always initially refuse to provide liability coverage for towing services unless there has been a significant release of hazardous substances, like diesel fuel, from an overturned truck. But it does not take a massive release of petroleum or a multi-vehicle accident to trigger these policies.

Here are some of my tips for securing coverage for towing services under a liability policy:

Tip #1 – Document all damage. To secure this coverage, you need to document all potential “property damage” using pictures or line items in your invoice. If a vehicle landed in a creek, take pictures. If a truck spilled its cargo all over the road and right-of-way, take pictures. If an overturned truck is leaking oil, gas, or some other fluid, take pictures and document that absorbents were used, even if it is not enough to report. Each of these, among others, constitute “property damage” that triggers coverage. But you need to document the “property damage.”

Tip #2 – How much damage is required to trigger a liability policy? Some liability claims are easier than others. At one end of the spectrum, there are claims involving multiple vehicles or a significant release of hazardous substances. These almost always trigger liability coverage. At the other end of the spectrum, there are claims involving disabled vehicles on the side of the road. These are harder to secure coverage for. Most claims fall somewhere in the middle. I always emphasize environmental harm if there is any kind of release of substances into ground. If those conditions do not exist, I emphasize the loss of use of property where a crashed or overturned vehicle has come to rest. Any time you come to the scene of an accident, you should look at the scene and ask: has anything been damaged—whether that be the ground, a waterway, a guardrail, the road itself, or a farmer’s crops? If so, then submit a liability claim.

Tip #3 – Submit a claim to all of the insurers. Even if you think your towing services will be fully covered by the owner’s physical damage or cargo insurer, do not forget to submit the claim to the liability insurer. Every insurer is looking to minimize their exposure and shift liability elsewhere. Therefore, you should submit the claim to all potentially liable insurers and reach a resolution with each of them.

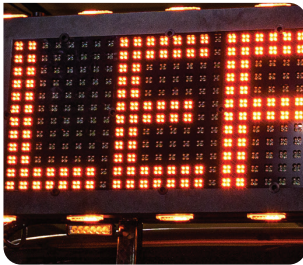
